

Summary of GAO Report: Federal Funding for Abortion Advocates (2019-2021)

EXECUTIVE SUMMARY

On December 12, 2023, the Government Accountability Office (GAO) released a report detailing the federal funding received by abortion promoting organizations over the course of three years (FY2019-FY2021). This report was requested by Members of Congress on January 18, 2022.

This summary uses GAO data to provide a snapshot of each of the national and international abortion providers named in this report: **Planned Parenthood Federation of America** (PPFA), **MSI Reproductive Choices** (MSI), and **International Planned Parenthood Federation** (IPPF).

These abortion advocacy groups received \$1.89 billion in federal funding. Most federal funding was disbursed through the Department of Health and Human Services (HHS) and the United States Agency for International Development (USAID).

Federal Funding Received by Abortion Advocates

Planned Parenthood Federation of America: \$1.78 billion \$1.53 billion of this funding comes from combined federal and state funds obtained through three federal programs (Medicaid, CHIP and Medicare).

International Planned Parenthood Federation: \$2.03 million
MSI Reproductive Choices: \$1.35 million
Four domestic regional organizations: \$107.74 million

TOTAL FUNDING FOR ABORTION ADVOCATES: \$1.89 BILLION

Note: "Federal funding received" underestimates funding received. It does not capture subgrants, subcontracts, or funding disbursed through the states.

The funds covered in this report are protected by the Hyde and Helms Amendments, protections in annual appropriations bills that ensure that funds are not used to pay for abortion. However, neither the Hyde nor Helms amendments limit funding for abortion providers. Federal funding of abortion providers expands the reach and influence of abortion advocates, giving taxpayers' stamp of approval to the agenda of abortion advocates.

PLANNED PARENTHOOD FEDERATION OF AMERICA

Overview of Planned Parenthood Federation of America

- Planned Parenthood Foundation of America (PPFA) is the nation's largest abortion provider. It has 49 affiliates and nearly 600 health centers.¹
- In fiscal year (FY) 2021, Planned Parenthood performed **374,155 abortions**.² This means that Planned Parenthood performed 1,025 abortions every day. It performed 1 abortion every 2 minutes. Between 2019-2021, Planned Parenthood performed **1.11 million abortions**.³
- In FY 2021, abortion made up 97.9% of the "services" that Planned Parenthood provided for pregnant women.⁴
- Planned Parenthood has killed over 9.3 million unborn children since 1970.5


Federal Funding Received by Planned Parenthood in 2019-2021:

- Between 2019-2021, Planned Parenthood received approximately **\$1.78 billion** in federal funding.^{6 7} This is an average of **\$592 million every year**.
- Planned Parenthood received this funding from three categories:
 - CHIP Reimbursements: \$1.53 billion⁸

 NOTE: Medicaid is a joint federal-state program, so this number does not reflect exclusively federal funding. Since 1972, the federal government has reimbursed states at 90% for all family planning services and supplies.⁹

Analysis of overall changes in Planned Parenthood's level of federal funding

Since the last GAO report was released for 2016-2018, Planned Parenthood's level of discretionary funding dropped significantly. However, its reimbursements from federal health programs grew, and it received \$90.4 million in forgivable loans from the Paycheck Protection Program. Overall, the federal funding Planned Parenthood received in 2019-2021 grew by \$170 million.

Top Funding Streams for Grants and Cooperative Agreements

35 Planned Parenthood affiliates reported expending 15 \$126 million in federal funding between 2019 and $2021.^{16}$

This amount is significantly lower than the reported expenditure by Planned Parenthood affiliates previously identified by GAO. In the last GAO report GAO report (covering 2016-2018), 39 Planned Parenthood affiliates reported expending approximately \$271 million.¹⁷

Between 2019 and 2021, the programs through which Planned Parenthood affiliates expended the most funding are listed below:



Impact of the Protecting Life Rule

Title X is Planned Parenthood's largest discretionary source of federal funding. On March 4, 2019, the Trump Administration published the final Protect Life Rule, which prevented Title X grantees from referring for abortion and required them to maintain physical and financial separation from abortion providers. Planned Parenthood refused to comply with these terms. The GAO found that this "led almost all affiliates to discontinue using family planning grants under Title X." 19



The Protecting Life Rule significantly reduced Planned Parenthood's access to those funds. Between 2013-2019, Planned Parenthood expended an average of \$57 million dollars through Title X every year.²¹ Between 2020 and 2021, it expended just \$4.7 million.

Funding from the Paycheck Protection Program

The Coronavirus Aid, Relief, and Economic Security ("CARES") Act (P.L. 116-36) provided funding for the Paycheck Protection Program (PPP). This program offered federally guaranteed, forgivable loans to help small businesses and non-profits retain their employees during the COVID-19 pandemic. It applied the Small Business Administration's <u>affiliation rules</u> to determine whether applicants qualified for this assistance. Businesses with more than 500 employees across all their affiliate entities (with a narrow exemption for hotels and restaurants) were ineligible for PPP funding.²²

As articulated in Rep. Claudia Tenney's November 2022 <u>letter</u> to the Inspector General of the Small Businesses Administration, pro-life Members of Congress argued that Planned Parenthood organizations should be considered affiliated because Planned Parenthood's corporate office exercises control over its affiliates and provides them with considerable funding and support.²³ Therefore, Planned Parenthood's 16,000 employees nationwide made it ineligible for PPP loans.

The Small Business Administration, however, chose to provide Planned Parenthood with PPP loans.

GAO found Planned Parenthood received \$90.4 million in forgiven PPP loans.²⁴ This diminished the purpose of the PPP, which was intended to assist truly independent small businesses.

INTERNATIONAL PLANNED PARENTHOOD FEDERATION (IPPF)

Overview of International Planned Parenthood Federation (IPPF)

IPPF is an international organization with 150 Member Associations that operate in 146 countries.²⁵ Abortion is central to IPPF's mission.

According to its most recent annual report, in 2022, IPPF provided 5 million "abortion-related services," an 11% increase from 2021. In 2005, IPPF provided 219,229 "abortion-related services." ²⁶ Just eighteen years later, IPPF provided 23 times more "abortion-related services." In 2022, IPPF member associations facilitated over 14,000 chemical abortions; this was three times more than the amount in 2021.²⁷

IPPF aggressively engages in pro-abortion advocacy. IPPF claims 28 "advocacy wins" promoting abortion in 2022.²⁸ Profamilia, the IPPF affiliate in Colombia "has campaigned for years to decriminalize abortion and played a key role in helping to bring about the [Constitutional Court] decision" in February 2022 to allow abortion within 24 weeks of pregnancy."29

Impact of the Protecting Life in Global Health Assistance on IPPF

In May 2017, President Trump's Administration implemented the "Protecting Life in Global Health Assistance (PLGHA)," which prohibited foreign aid funding from going to foreign nongovernmental organizations (NGOs) that promote or perform abortions.³⁰ PLGHA applied to approximately \$8.8 billion in global health assistance.³¹ President Joe Biden rescinded the policy in January 2021.³²

PLGHA did not reduce the amount of federal funding available for global health and family planning programs. Organizations could choose to give up their abortion activities and continue to receive U.S. grant money, or they could forfeit U.S. grant money if they continue to engage in abortion.

After PLGHA was established, IPPF publicly stated that it was unwilling to comply with the terms.

IPPF later stated, "At the time of the reinstatement of the Global Gag Rule (GGR) in January 2017, IPPF had 53 projects operating in 32 countries in Latin America and the Caribbean, Sub-Saharan Africa, and South Asia."33 It reports losing \$100 million when it declined the terms of PLGHA and withdrew from funding.34 It states that services provided by Member Associations decreased up to 42% from 2016-2017.35

Funding for IPPF between 2019-2021

Between 2019-2021, IPPF received approximately \$2 million in federal funding.³⁶

Even though IPPF had forfeited new federal funding by refusing to comply with PLGHA, GAO explains that the \$2 million dollars had been previously obligated. It notes, "Federal funding obligated to an organization in any 1 year may be received by the organization in a different year or across multiple years."³⁷

\$2 million dollars represents a significant drop in federal funds received since 2013, as shown below:

MSI REPRODUCTIVE CHOICES (MSI)

Overview of MSI Reproductive Choices (MSI)

MSI is an international organization that operates in 37 countries.³⁹ It states that providing abortions is part of its "one aim."⁴⁰ MSI reported that in 2020 it provided 4 million "abortions and post-abortion care services."⁴¹ MSI states that, by 2030, it aims to provide 1 out of every 3 abortions in the countries where it operates.⁴²

MSI advertises providing chemical and surgical abortions at its own <u>service centers</u>, through partnerships with private sector health providers (called "<u>social franchising</u>"), and through local pharmacists and community health workers that <u>MSI boasts</u> it has "trained to provide medical abortions."⁴³

MSI was established in 1976 as Marie Stopes International. It was named after the woman who founded the first birth control center in Britain and supported the eugenics movement. In 2020, after forty-four years, MSI acknowledged Marie Stopes' ties to the eugenics movement and officially removed her from its name.⁴⁴

MSI's "<u>Scaling Up for Excellence</u>" report proclaimed the organization's goal to double provision of medical (chemical) abortion by 2020.⁴⁵ To do so, MSI commits to "work to remove policy and clinical restrictions that limit access to… abortion"⁴⁶

MSI <u>seeks to overturn</u> pro-life laws in other nations. It <u>takes credit</u> for expanding the number of legal indications for abortion in Sierra Leone, Malawi, and Bolivia, expanding chemical abortion in the Democratic Republic of Congo, and progress toward "public financing of reproductive health service in

Jigawa State, Nigeria."⁴⁷ In its 2020 Annual Report, says its "Scaling Up for Excellence" strategy contributed to "removing a total of 56 policy restrictions."⁴⁸ In 2020, it takes credit for removing "six policy restrictions" dealing with abortion in Malawai, Burkina Faso, Kenya, Madagascar, and Mali.⁴⁹

Impact of the Protecting Life in Global Health Assistance on MSI


In May 2017, President Trump's Administration implemented the "Protecting Life in Global Health Assistance (PLGHA)," which prohibited foreign aid funding from going to foreign nongovernmental organizations (NGOs) that promote or perform abortions. PLGHA applied to approximately \$8.8 billion in global health assistance. President Joe Biden rescinded the policy in January 2021.

Like IPPF (described above), MSI stated that it was unwilling to comply with the terms of PLGHA and forfeited federal funding.

Funding for MSI between 2019-2021

Between 2019-2021, MSI reported receiving \$1.35 million in federal funding.⁵⁰ Despite refusing to accept the conditions of PLGHA, MSI was allowed to expend any previously obligated funds.

\$1.35 million dollars represents a significant drop in federal funds received since 2013, as shown below:
